# TENDER NOTICE

Tanathi Water Works Development Agency is a state corporation under the ministry of water, sanitation and irrigation created under section 51 of the water act 2002 vide legal notice No. 69 dated 4<sup>th</sup> June 2008. The board has the legal mandate of ensuring efficient and economical provision of water services within its area of Jurisdiction which covers Kajiado, Makueni, Machakos and Kitui Counties.

Tenders are therefore invited from eligible contractors registered with the National Construction Authority (NCA) for water works as detailed below:-

The bidding will be conducted through the National Competitive bidding procedures specified by the Government of Kenya Public Procurement and Asset Disposal Act 2015, [www.ppoa.go.ke](http://www.ppoa.go.ke).

### QUALIFICATION REQUIREMENTS

Interested bidders should note that only those meeting the criteria indicated below as minimum, supported by the relevant documents at submission will be considered for further evaluation:-

1. Provide certified copies of Company registration, VAT, PIN and Valid TAX Compliance Certificate;
2. Certified copy of a valid certificate of registration in a target group issued by the National Treasury;
3. Certified copy of valid registration certificate with the National Construction Authority in the categories specified above and a valid practising licence;
4. The Form of Tender and Confidential Business Questionnaire must be fully filled and signed by authorized person(s) with full names of Directors/Owner(s), Names of proprietors(for sole proprietors) and names of partners (for partnerships), copies of their National Identity Cards, copies of Business Registration Certificates and copy of business permit/licences;
5. Proposals for the timely acquisition( own, lease, hire etc) of the essential equipment;
6. Experience as prime contractor in the construction of at least 2 works of similar nature and complexity equivalent to the works over the last 5 years (to comply with this requirement, works cited should be at least 70% completed);

7. Liquid assets and/or credit facilities net of other contract actual commitments and exclusive of advance payments which may be made under the contract of no less than Kshs. 40,000,000 Million;
8. Bidders are required to comply with section 74(1)(i) of Public Procurement and Asset Disposal Act 2015. That makes it mandatory “requirement for serialization/pagination of bid documents by the bidder” for each bid submitted.
