INVITATIONS FOR BIDS

Tanathi Water Services Board is a state corporation under the ministry of water and sanitation created under section 51 of the water act 2002 vide legal notice No. 69 dated 4th June 2008. The board has the legal mandate of ensuring efficient and economical provision of water services within its area of Jurisdiction which covers Kajiado, Makueni, Machakos and Kitui Counties.

Tenders are therefore invited from eligible contractors registered with the National Construction Authority (NCA) for water works as detailed below. Preferences shall be accorded to firms belonging to Youth, Women and People living With Disabilities in accordance with Public Procurement and Asset Disposal Act 2015.

The bidding will be conducted through the National Competitive bidding procedures specified by the Government of Kenya Public Procurement and Disposal Act 2015, www.ppoa.go.ke and is open to all bidders registered in Kenya as defined in the bidding documents.

QUALIFICATION REQUIREMENTS

Interested bidders should note that only those meeting the criteria indicated below as minimum, supported by the relevant documents at submission will be considered for further evaluation:-

1. Provide copies of Company registration, VAT, PIN and Valid TAX Compliance Certificate;
2. Be registered with the National Construction Authority (NCA) under category NCA 6 and above as water works contractors and also registers with the Ministry of water and sanitation class D and above must attach copies of registration certificates as proof and current licence
3. The Form of Tender and Confidential Business Questionnaire must be fully filled and signed by authorized person(s) with full names of Directors/Owner(s), Names of proprietors(for sole proprietors) and names of partners (for partnerships), copies of their National Identity Cards, copies of Business Registration Certificates and copy of business permit/licences.
4. Proposals for the timely acquisition(own, lease, hire etc) of the essential equipment
5. Experience as prime contractor in the construction of at least 2 works of similar nature and complexity equivalent to the works over the last 5 years (to comply with this requirement, works cited should be at least 70% completed)
6. Liquid assets and/or credit facilities net of other contractual commitments and exclusive of advance payments which may be made under the contract of no less than Kshs. 20,0000
7. Bidders are required to comply with section 74(1)(i) of Public Procurement and Asset Disposal Act 2015. That makes it mandatory “requirement for serialization/pagination of bid documents by the bidder” for each bid submitted.
8. A mandatory pre- tender visit shall be held on Monday 28th January 2019 in respective county head quarter for projects within Makueni, Machakos, Kitui and Kajiado counties at 10. Am.

Eligible bidders may download the Tender Documents from the **Tanathi Water Services Board website (www.tanathi.go.ke) and National Government Portal (www.tenders.go.ke) free of charge** with effect from **Friday 18th January, 2019**.

Bids shall be valid for a period of 90 days after bid opening and submission of Tenders **must** be accompanied by a **bid security of 2% of the contract sum** . For firms belonging to Youth, Women and Persons Living with Disabilities no bid security would be required; however this category of businesses shall be required to sign a Bid Security Declaration Form to be provided to the eligible applicants.
