1. Tanathi Water Works Development Agency (TAWWDA) has received financing from the Government of Kenya through the Ministry of Water and Sanitation for the **CONSTRUCTION OF WOTE WATER SUPPLY AUGMENTATION PROJECT - PHASE I**

Tender No: **TAWWDA/065/2019-2020**

2. Bidding will be governed by the Government of Kenya Public Procurement rules and Procedures (**The Public Procurement and Asset Disposal Act 2015; www.ppoa.go.ke**).

The works shall comprise but not limited to the following:

- i. **Supply and Installation of various sizes of distribution network pipelines approximately 4 Km**
- ii. **Construction of 100 M³ Clear water tank at Kamunyolo Treatment Works**
- iii. **Rehabilitation of Kamunyolo Treatment works including: fencing, replacing filter media, repair of backwash tank e.t.c**
- iv. **Reinstatement of sections of DN 150 GI rising main from Kamunyolo water treatment plant to Makueni Boys' tanks.**
- v. **Rehabilitation works for Mwaani boreholes. to include provision of a stand-by generator at booster station and borehole No. 3, repair of airvalves and wash outs along the pipeline e.t.c**
- vi. **Construction of 4 No. water kiosks.**
- vii. **Supply of assorted repair kit to WoWASCO.**

3. Tanathi Water Works Development Agency now invites sealed bids from eligible and qualified bidders to undertake the works described above. The delivery/construction period is **12 months.**

4. Bidding will be conducted through the National Competitive Bidding procedures specified by the Government of Kenya Public Procurement rules and Procedures (**The Public Procurement and Asset Disposal Act 2015; www.ppoa.go.ke**), and is open to all bidders registered in Kenya as defined in the Bidding Documents.

6. The Application must be clearly marked “**Tender for Construction of Wote Water Supply Augmentation Project - Phase I TAWWDA/065/2019-2020**”

7. Qualifications requirements include:

(a) Experience as prime contractor in the construction of at least **2 works** of a nature and complexity equivalent to the Works over the last **5 years**.

(b) Proposals for the timely acquisition (own, lease, hire, etc.) of the essential equipment

(c) Liquid assets and/or credit facilities, net of other contractual commitments and exclusive of any advance payments which may be made under the Contract, of no less than **KSh 120,000,000**

(d) Only firms registered with the National Construction Authority under category NCA 1 to NCA 4 (WATER OPTION) shall be eligible for this tender.

8. A consistent history of litigation or arbitration awards for the Applicant or any partner of a Joint Venture may result in disqualification.

9. Bids must be delivered to the address below at or before **1200 hours East Africa time on 28th July 2020**. Late bids will be rejected and returned to the Bidder un-opened. Bids will be opened physically in the presence of the bidders or representatives who choose to attend in person at the address below.

10. A pre-tender site visit shall be held on **14th July 2020** at Wote Water Company offices in Makueni at **1000Hrs.**

11. All bids shall be accompanied by a **Bid Security of Kshs 800,000** (or equivalent amount in freely convertible currency).
