The proposed project is located at Namanga in Kajiado County.

The objective of this advert is to engage a consulting firm to undertake Detailed Designs and preparation of Tender Documents for:

- 20m High Dam and intake works
- Water Treatment Plant 6000m³/day
- 12km Transmission mains
- 25km Distribution network and storage tanks
- Rehabilitation of existing water supply system

The overall objective of the assignments is as follows:

- i. Review preliminary designs for Namanga dam
- ii. Perform hydrological studies
- iii. Perform Geotechnical investigations
- iv. Prepare Detailed Designs for Namanga Town and environs water supply
- v. Prepare Detailed Designs for Namanga Town Sewerage system
- vi. Prepare Cost Estimates and tender documents
- vii. To provide the client with regular status reports and other reports as per the Terms of Reference, together with all related necessary technical assistance and professional advice to the Client related to design of the said works;
- viii. Carry out RAP and ESIA for the proposed project.

The Consultancy Services will be carried out over a period of 6 (Six) months.
