SECTION II - INSTRUCTIONS TO CANDIDATES

2.1 Scope of Tender

2.1.1 The Tanathi Water Works Development Agency (TAWWDA) hereinafter referred to as the procuring entity intends to register suppliers for the: **Provision of insurance services for medical cover, Group Personal Accident, Group life and Motor Vehicles**

2.1.2 It is expected that registration applications will be submitted to be received by the procuring entity not later than **8th September 2026** at 12.00 hours

2.1.3 Registration is open to eligible suppliers as indicated in appendix to instructions to candidates.

2.2 Submission of Application

2.2.1 The name and mailing address of the applicant may be marked on the envelope.

2.2.2 All the information requested for registration shall be provided in the English language. Where information is provided in any other language, it shall be accompanied by a translation of its pertinent parts into English language. The translation will govern and will be used for interpreting the information.

2.2.3 Failure to provide information that is essential for effective evaluation of the applicant's qualifications or to provide timely clarification or sub substantiation of the information supplied may result in the applicant's disqualification.

2.3 Eligible Candidates

2.3.1 This invitation for registration is open to all candidates who are eligible as defined in Kenya's Public Procurement Law and regulations and as indicated in the appendix to instructions to candidates.

2.3.2 The procuring entity's employees, committee members, board members and their relative (spouse and children) are not eligible to participate in the tender unless where specially allowed under section 131 of the Act.

2.3.3 All firms found capable of performing the contract satisfactorily in accordance to the set registration criteria shall be prequalified.

2.4 THE TENDERERS SHOULD MEET THE FOLLOWING MANDATORY REQUIREMENTS (QUALIFICATION CRITERIA)

- 2.4.1 Registration will be based on meeting the minimum requirements. The declaration will be either pass or fail regarding the applicant's general and particular experience, personnel and equipment capabilities and financial position as demonstrated by the applicant's response in the forms provided in Section IV and submitted with the letter of application. The procuring entity reserves the right to waive minor deviations if they do not materially affect the capability of an applicant to perform the contract.
- 2.4.2 Be registered under the relevant Statutes (Contractors certificate from the Ministry of Water, Irrigation and Sanitation)
- 2.4.3 Be registered under the relevant class with NCA National Construction Authority
- 2.4.4 Current Tax Compliance Certificate from KRA
- 2.4.5 Current single business permit from local authority
- 2.4.6 CR12 Certificate
- 2.4.7 Proof of similar works undertaken in the last 3 years
- 2.4.8 Profile of Key personnel
- 2.4.9 Litigation history: the applicant should provide accurate information on any litigation or arbitration resulting from contracts completed or under its execution over the last five years. A consistent history of awards against the applicant may result in failure of the application.

2.5 Public Sector companies

- 2.6.1 Any public owned enterprise may be eligible to qualify if, in addition to meeting all the above requirements, it is also legally and financially autonomous, it operates under commercial law, and it is not a dependent agency of another public entity.

2.7. Conflict of Interest

- 2.7.1 The applicant shall not be associated, nor have been associated in the past, with the consultant or any other entity that has prepared the specifications and other registration and bidding documents for the Board. Any such association must be disclosed and may result in the disqualification of the applicant.

APPENDIX TO INSTRUCTIONS TO CANDIDATES

The following instructions for the registration of candidates shall supplement, complement or amend the provisions of the instructions to candidates.

Where there is a conflict between the provisions of the instructions to candidates and the provisions of the appendix, the provisions of the appendix herein shall prevail over those of the instructions to the candidates.
